# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.slateenterprises.org, and Slate Enterprises LLC and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered, Slate Enterprises may collect personally identifiable information, such as your:

- Comply with an existing legal obligation; or
